John Mayne purchased of Richard Carter, Sen., his interest in home and lands at Westcustogo Royal River, Casco Bay, Me., in the year 1652.

From Plymouth Colony Records is taken the following:

Ezekiel Mayne of Scituate was summoned before Court to give "his witness" in the marriage of Robt. Whitcomb and Mary Cudworth, June 10, 1661 (Vol. 2, p. 93).

In 1666, Ezekiel Mayne was called in the case of Mary, wife of Tom Totam, town of Scituate.

In 1660-1661, Ezekiel Mayne was fined one pound (\$5.00), and same year was excused from military duty because he had only one eye.

This indenture made in the 20th Reign of our Sovereign Lord, Charles II, by the Grace of God of England, Scotland and Ireland, defenders of the faith. That I, John Deaman, of Kittery, York Co., Maine, do for divers and sundry considerations of the sum of four score and fifty pounds in hand paid, whereof I acknowledge, do Bargain and Sell to Henry Maine and Andrew Deaman, their heirs and assigns forever, both of the Isle of Shoals, all the Stage Moorings, dwelling houses and two out houses, anchors, cables,
