Indenture 23 Feb 1769 between THOMAS CHEW and JOHNNY SCOTT .. sells 200 acres .. adjoining land of Johny Scott and Robert Martin and Mr. Beale and Mr. James Madison .. for five shillings .. land may be claimed under the right of Thomas Chew by virtue of a patten granted to Ambrose Madison and Thomas Chew for a larger quantity .. to prevent all claim to the land .. said Chew .. has granted all his right 200 acres unto Johnny Scott.

This Indenture made 2nd January 1790 between AMBROSE MADISON Guardian of the children of EDWARD and FRANKY HOBDAY and Attorney in Fact for the representatives of ANN WHITE of one part. and JOHNNY SCOTT Attorney in Fact for NANCEY YOUNG and JANE YOUNG of the second part and ROBERT MARTIN and GEORGE MARTIN of the third part W itnesseth that in consideration of the sd Robert Martin being indebted to the sd Ambrose Madison as Guardian to the Children of Edwd. and Franky Hobday in the sum of Seventy two pounds as the Proportion of the Estate of ROBERT MARTIN deceased and in the sum of forty pounds due from the sd Robert Martin as Administrator of the Estate of
