

Born 1678 in Ås, Norra Råda fs, Värmlands län. [1] Died 1756-03-21 in Ålebyn, Norra Råda fs, Värmlands län. [1] Cause of death: Weakness of old age. Buried 1756-03-28 in Norra Råda fs, Värmlands län. 20. It was initiated between the brothers Jon Jönsson and together with Per Jönssöner and Nils Jönsson on behalf of themselves and their nephew Petter met association in NM Per Arvidsson in Mjönäs presence, when they due to the court's resolution school were together in Ås and Råda sn on 13.3 1733, whereby they thus agreed that Nils Jönsson, for the inconvenience and art he had with his mother's funeral, would be allowed to keep a horse saddle, sleigh and a half bed as an exception to the previous exchange, along with its dead brother Olof Jönsson's walking clothes, as he also (?) freedom to keep, later the other movable property after their mother and brother was divided by law into 13 parts, of which each brother got 2/13 and each sister 1/13 through Nils Jönsson got an English shirt, Jon Jönsson a trap and a striped cloth, whereupon he must pay to his brother Per 1 dlr smt, then fell on Per Jönsson's share a (blanket?) robe, 2ne headgear and a vest apron, Jöns Jönsson got a blanket, Jonas Persson a kj ortel of patterned clothing, the sisters Karin and Marit Jönsdöttrar got a bolster, for which they have to pay brother Per Jönsson 16 mk kmt and to brother Nils 3 d = o kmt, but Kerstin Jönsdotter got a new sweater and a (chip line?). Of the cattle, Nils Jönsson's share came a cow, Jon Jönsson's share a heifer, but Jöns got 6 small cattle, Per Jönsson a cow, Jonas Persson 6 small cattle, Karin and Marit Jönsdöttrar a year old steer, Kerstin Jönsdotter 3 small cattle. Then 1/7 rye was exchanged between the siblings on each brother and 2 coats ditto on each sister. thus, on top of that, an application made about it was entered in the court minutes and extracts were submitted. [105] 6/15 in 2/3 of 1/4-hmt Ås and Råda sn, of which after the tribunal's witness Nils Jönsson inherited 2/15 in addition - - - April in 1715 from his brother Per Jönsson acquired 2/15 in the said 2/3 for 9 Rd ct, and on 22 and 28.2 1723 by his sisters Marit Jönsdotter in Backa and Karin Jönsdotter in Åleby and their husbands Per Andersson and Per Nilsson their respective 2/15 for 6 Rd ct and 12 öre smt paid purchase price for each 1/15 according to the purchase letter received during the
