Stean of Pailton in the Parish of Monks Kirby in the County of
Warwick Husbandman, being of perfect Mind and Memory God be thanked,
do make and ordain this my last Will as follows, That is to say
First I give the Sum of Fifty Pounds unto Thomas Buswell Gentleman
and Peter Payne Weaver of Pailton aforesaid In Trust to continue the
same at Interest, and pay the Interest thereof as the same becomes due
unto Elizabeth Wife of John Cishbon my Eldest Daughter, ^{during her life} and not to or
the use of her said Husband, and from and after her decease I give In Trust
Forty five Pounds out of the said Sum unto the Surviving Children of my
said Daughter to be equally shared amongst them, And the five Pounds
that remaineth of the aforesaid Fifty I give In Trust unto my Daughter
Alice Stean after the decease of my said Daughter Elizabeth. Also I
give unto the said Thomas Buswell and Peter Payne the like Sum of
Fifty Pounds In Trust to continue the same at Interest, and pay the
Interest thereof as the same shall become due unto my Daughter Ann
Wife of Thomas Childs during her natural Life, and from and after her
decease I give In Trust Forty five Pounds out of the said Sum unto all
the Surviving Children (Daniel Miller excepted) of my said Daughter Ann ^{equally amongst them}
and the remaining five Pounds of the said Sum of fifty I give In Trust unto
my Daughter Frances Wife of Peter Payne aforesaid after the decease of my
said Daughter Ann, Also I give unto my said Daughter Alice Stean the
Sum of Forty Pounds and I likewise give unto my Daughter Frances
aforesaid the Sum of Forty Pounds, I give unto my Grandson Robert Miller the
Sum of Five Pounds and all my Shirts, Also I give unto the said Thomas
Buswell the Sum of ^{great} one Guinea, and unto the said Peter Payne one Guinea
together with my best Coat and best Breeches, I give unto my son in law John
Cishbon my second best Coat and waistcoat, and unto my son in law Thomas
Childs my third best Coat and waistcoat, And further I give unto my said
Daughter Alice the Bed and furniture belonging thereto with two pair
of Sheets, the Chest all standing in my Room and the little Table standing
in her Room, and my Will further is that the five last mentioned Legacies
shall be paid within six Months after my decease. And lastly I give
unto my son Thomas Stean all the Residue and Remainder of my Person-
al Estate Money Goods Stock of Cattle and Chattels whatsoever my
Debts Legacies and Funeral expences being first paid And I do
hereby appoint my said son Thomas Stean together with

Thomas Buswell Gentleman and Peter Payne aforesaid joint. Executors
of this my Will and Testament. and I Daniel Stearn the Testator, do
confirm this to be my last Will and Testament. In Witness whereof
I have hereunto set my Hand and Seal this first day of November
in the Year of our Lord One Thousand Seven Hundred and Seventy four.

I Daniel Stean of Pailton in the Parish of Monteburgh in the County of Warwick Husbandman, do this seventh Day of October make and publish this Codicil to my last Will and Testament, in manner following, (that is to say) Whereas in and by my last Will and Testament I have given in Trust unto Thomas Knewell Gentleman and Peter Payne Weaver the sum of Fifty Pounds for the Interest, to be paid to my Daughter Elizabeth during her life, and at her decease Forty five Pounds of the said sum to be equally ^{shared} amongst her surviving Children, and also the sum of Fifty Pounds, the ^{Interest} whereof is to be applyed to the use of my Daughter Ann and at her decease Forty five Pounds out of the said sum to be equally shared amongst her surviving Children, excepting as before excepted I do hereby order and my Will is that the Survivor of my said two Daughters Elizabeth and Ann shall have the Interest of the Forty five Pounds during her life, instead of the said first deceased Children, and after the decease of both my said Daughters then to divide the respective sum amongst their respective Children as aforesaid. And whereas I gave in my said ^{Will} unto my Daughter Alice now Wife of Leptaniak Binley certain Goods and Legacies, I do hereby give her the Legacies as aforesaid only, and whereas in my Will I gave unto my son in law John Ashbon one Coat and Waistcoat I do hereby give him instead thereof my Mourning Suit. And lastly it is my Desire that this my present Codicil be annexed to and made a part of my last Will and Testament, to all Intents and Purposes. In Witness whereof I have hereunto set my Hand and Seal this seventh Day of October in the year of our Lord One Thousand Seven Hundred and Seventy five.
