

Whereas John Hough junior, Son of John Hough of Middletown in the County of Bucks in the Province of Pennsylvania, and Elin Sands Daughter of Stephen Sands of Bensalem township in the aforesaid County, Having declared their Intentions of taking oath otherwise in Marriage before several publick Meetings of the people called Quakers in their publick Meeting-house in Middletown aforesaid, according to the good order used amongst them, Whose proceedings therein (after deliberate Consideration thereof, with regard to the righteous Law of god, and Examples of his people recorded in the Scriptures of Truth in that case) were approved of by the said Meetings, they appearing there of all others, and having Consent of Parents and Relations contrary, Now these are to Certifie to all whom it may concern, That for a full accomplishment of their said Intentions this first day of the fourth month in the year (according to English account) one thousand seven hundred and fourteen, They the said John Hough and Elin Sands appeared in a solemn and publick Assembly of the aforesaid people met together for that purpose in their publick Meeting-house in Middletown aforesaid, and in a solemn manner has the said

 to be her Husband, promising to be unto him a faithfull  
 and loving Wife untill it please the Lord by death to sep-  
 rate them; And the said John Hough and Elin (assuming  
 the name of her Husband now Elin Hough) as a further  
 confirmation therof did then and there to these presents  
 set their hands. And wee whose names are hereunto sub-  
 scribed being present amongst others at the solemnizing  
 of their said Marriage and subscription in manner afores-  
 said, as Witnesses therunto have also subscribed our names  
 this day and year above writton.
