Samuel and James Spilman. Codicil to will "I did not intend to set free my old man Daniel Tucker as he is too old and crazed to be liberated, therefore it is my will and desire that my wife keep said Daniel Tucker and take care of him as long as he may live or some suitable arrangement for him by selling or giving him to some person who will take good care of him in his old age. This is done for the benefit of Daniel as he would not be capable of taking care of himself." 14 Aug. 1860. Wits. W. Samuel, Wm. J. Perkinson, Joseph Coleman.

PENN, HENRY: 1 June 1859: Probate August 1859: Will. Henry Penn, wife Delilah, "my needy children and grandchildren", daughter Malvinna, three grandchildren James Duncan, Delilah Duncan, Minerva Duncan, two sons John and Henry Penn the land I now live on, the rest of my money and estate to belong to my daughters. Wits. F. A. Smith and Henry McElwain. "Rest of my children".

PERKINSON, SILAS E.: 7 April 1863: Probate 11 May 1863: Will. Wife Darcus Jane, "My children Albert F., Alice and Silas". Wits. William J. Perkinson and Wm. Samuel.

PERKINSON, JOHN: 2 April 1860: Probate 11 June 1860: Will. Wife Mary J. Perkinson, daughter Elizabeth Hood wife of Allen Hood to have 77 acres of land where she now lives. Son Coleman H. Perkinson 77 acres where he now lives. Son William J. Perkinson to have 76 acres. Daughter Polly Ann Suttle, wife of Strother Suttles th have 83½ acres where she now lives. Son Silas E. Perkinson to have 186 3/4 acres (40 3/4 being the same bought by my deceased son John from A. H. Talbertt, survey of 14 January 1857), the reason I give Silas more is my son John on his deathbed requested me to give Silas at my death the lands he (John) had bought. My three sons to take care of and manage for my wife so long as she may live. Wits. J. S. Greenwood and Wm. Samuel.

LOUDON, WILLIAM: 18 May 1859: Probate 14 November 1859: Will. Wife Milly Loudon, "my infant children", friend Sanford C. Yager, exor. Wits. Wm. R. Morgan and John J. Morgan.

HOAGLAND, ISAAC: 31 July 1861: Probate 12 August 1861: Will. Beloved wife Eliza Hoagland. Wits, S. C. Yeager, H. Rouner.

STATEN, JAMES: 20 December 1855: Probate 11 February 1856: Will. Wife Mary Staten, sons William and A. J. Staten \$100 each. My children Joseph Staten, America Brent, James M. Staten, Mary J. Colbert, Emaline Abbott, Martha Colbert, William and Andrew J. Staten, Matilda Colbert, Sarah A. Tucker's children to have the part of their mother. Son Newton C. Staten, to have the farm on which I now reside upon condition that he provide well for his mother, Mary so long as she lives and pay the above named 10 children \$50 each, that is, Jas. Staten's nine living children as above named \$50 and Sarah Tuckers children altogether \$50. Wits. Wm. C. Sams & Jas. Moore.

All money from 21 acres of land to be equally divided among my seven children and Sarah Hankins (the daughter of my late husband by his first wife, one eighth to each heir namely, Marion Hoagland, Mary O'Brien, John A. Hoagland, Edward C. Hoagland, Phillip M. Hoagland, Martha Hoagland and Amanda J. Hoagland and Sarah Hankins. The court of Trimble County to appoint some suitable person to carry out the provisions of this my last will and testament. Wits. W. T. Dejarnett and J. R. O'Brien.

LOGAN, JOSEPH A.: 1 May 1870: Probate 12 July 1870: Will. To wife Charlottie my whole estate as long as she remains my widow. After her death my estate to be equally divided among my children, Martha Jane Penn, S. W. Logan, James W. Logan, and Benjamin Crouch Logan. Wife Charlottie extrx. Wits. John W. Stewart and W. O. Callis.

CRAIG, DELB: 19 Sept. 1864: Probate December 1864, Jefferson County, Indiana. "Of the town of Manneopolis in the county of Hennessia and State of Minnesotia". To my beloved wife, Nettie F. Craig of the town of Minneopolis all my estate, wife Nettie to be executrix and guardian of my two children. Signed DeKalb Craig. Wits. J. Shiffent Burd and W. K. M. Farland residing at Minneapolis and John C. Miller residing at Madison, Indiana and Geo. C. Patton, residing at Vevay, In.

MAYFIELD, BURDITT: 8 March 1861: Probate 14 November 1870: Will. To wife Polly Mayfield all my estate, both real and personal. To my daughter Mary C. Mayfield one bed, bedstead and bedding to make her equal with my other children; To my son Irvin Mayfield two hundred dollars and to my daughter Mary C. Mayfield two hundred dollars; to my children towit; Wyatt Mayfield, Sallie Fisher, Eliza Trout, Pauline Coleman, Irvin Mayfield, Benjamin C. Mayfield, Mary C. Mayfield and Hannah Trout. Exor. Son Irvin. Wits. Baxter Mayfield, John S. Maddox and J. H. Moffett.

MAYFIELD, ELIZABETH: Written 1850: Probate August 1871: Will. To my brother Baxter Mayfield all my estate. To my brother Madison Mayfield the full amount he may be owing me at my decease. I desire no administration of my estate, but at my decease for my brother Baxter to deliver to my brother Madison the notes, bonds or accounts which I may hold against said Madison. Wits. Fredric F. Mayfield, Julia Ann Floyd, J. R. Barclay and A. M. King.

McGEE, WILLIAM S.: 23 March 1864: Probate September 1871: Will. To my wife Catherine McGee my house, farm & all stock, horses, hogs, cattle, farming utensils and house hold & kitchen furniture as long as she may live. My wife to sell my land in Christian County, Illinois. After the death of my wife all estate to be divided equally between my children. My daughter Mary S. McGee to have when the eatate is sold \$800; and Martha McGee \$800; and Angaline McGee \$800; and my granddaughter Mary Frances
