

## ANTTI MULIKKA AND HIS DESCENDANTS

Proceedings of the Assemblies: "An Act for Naturalization of Andrew Poulson als. Mullock, Simon Johnson, Peter Anderson, and Mathias Peterson read and passed this house and sent to the Lower House by Coll Burgess who returns having delivered the same."

Andrew purchased in 1662 about 50 acres of land near Sahakitko. He sold his farm called as "Successor" in July 1690. The land was known as Hollingworth's Elk Landing. It was the historical trade center of Elkton.

**VI Cornelius Poulson**, farmer, b. 1694 Maryland, Baltimore, Harford County, d. 1780 Maryland, Baltimore, St. Johns Parish. Cornelius' first farm "Elberton" was from his wife's family. He sold the farm in 1748. He bought a new farm "Poulsin's Change" in 1746 in Frederick Cty. The farm was located 4,5 miles SW of Westminster MD.

Also recorded was the farm expansion to 274 A. by 1790 which included the 100 A. farm "Arnold's Chance". The combined farm was renamed "Poulson's Reserve". (L. O. I. C. No 2, Folio 227, 1803).

By 1798, this had been enlarged and combined with ownership by son Andrew as follows: Cornelius owned 86.5 A. and Andrew owned 187.5 A. of this farm then named "Polson Reserve". Source: "Particular Assessment of Baltimore and Carroll County, 1798", by George Horvath.
