Note I.—Question No. 12 will only be asked in cases where an affirmative answer has been given either to question 10 or to question 11.
Note J.—Question No. 14 will only be asked in cases where a particular occupation has been reported in column 11.
Note K.—In column 7 an abbreviation in the case of the month may be used, as Jan., Apr., Dec.
