Will of Jacob Binder Decd

In the name of God Amen, I Jacob Binder of Turbot Township Northumberland County State of Pennsylvania being of sound disposing mind memory and understanding, do make and publish, this my last Will & Testament in manner of form following viz Principally and first I recommend my soul into the keeping of God, who grant it and my body to be buried in a decent and Christian like manner:

Then I order and direct that all my just debts and all other debts which may hereafter accrue during sickness and funeral expenses be duly paid and satisfied as soon as conveniently can be after my decease by my executors hereinafter named.

Then I order and direct that my executors shall sell (and collect the proceeds) my share which I hold, in real estate, consisting of two lots and a dwelling house situate in Borough of McEwenville, said County of Northumberland and also all my personal property which I

shall possess at my decease, within one year from the time of my death, when distribution shall be made as herein after stated

Item I hereby authorize and empower, my executors to make title for my share of real estate herein directed to be sold, which shall be held as valid in law, as though I had made it during my life.

Item I order and direct, that the amount of the proceeds of my real and personal estate bonds, notes, and my interest and principal in the Holsenier Building association or any other credits, I may have at my decease after deducting all my just debts funeral expenses and expenses for settling up; this my estate shall form the aggregate for distribution, among my children and two grand children; the balance remaining after making the deductions as stated above shall be divided in seven equal shares.

Item I give and bequeath one share (1/7) to my son John; one share (1/7) to my son Jesse; one share (1/7) to my son David; one share (1/7) to my son William; One share (1/7) to my two grand daughters; Anna Jane Menges; minor children of my daughter Sarah Reed; One share (1/7) to my daughter Maria wife of Thomas Barber; and one share (1/7) to my daughter Amy wife of Nathan Baker and to their heirs and assigns forever.

Item I nominate constitute and appoint "Daniel Menges" the father of my two grand daughters "Anna" and "Emma Jane" to be their guardian during the years of their minority.

Item I nominate constitute and appoint my two sons "John" and "Jesse" to be the executors of this my last Will.

And in Witness Whereof and to the identity of this my last Will Testament, I have hereunto set my hand and seal this last day of June A.D. 1870 one thousand eight hundred and seventy four
