CAPE GIRARDEAU COUNTY, MISSOURI

The county of Cape Girardeau was established as one of the original counties in Missouri in 1812. The town of Cape Girardeau, however, was laid off into streets and lots sometime in February or March of 1806 by Bartholomew Cousin, under the direction of the proprietor, Louis Lorimier. By 1808, the town of Cape Girardeau was incorporated with five trustees elected on 13 August 1808. These were Joseph McFerron, Anthony Haden, Robert Blair, Daniel F. Steinbeck and Isaac M. Bledsoe.

The enclosed materials cover the time period from 1805 - 1838.
