Desire all and any of my real and personal to be disposed of by my executor after payment of my just debts. To my wife Mary McNairy my negro man George for her support during her natural life, after death I will said negro man to Boyd McNairy and his heirs, also all my household and furniture &c. To my son Boyd McNairy a tract of land in Williamson County which is out of a 5000 acre tract granted to George Parks and his heirs. To the sons and daughters of Thomas Thomas Hamilton and to the sons and daughters of Elisha Nicholson all of my property of real or personal to be equally divided between them. I will that my executor dispose of as much of my personal estate as will purchase a plain ring for each of my daughters and daughters-in-law to be kept in remembrance of me. I appoint John McNairy my executor. This 15 Nov 1807. Wit: Francis Collier and John Thompson.
