

PEDIGREE LXI.

1.—**EDWARD I.**, King of England, had by his first wife, Princess Eleanor, only child of Ferdinand, King of Castile :

2.—**PRINCESS ELIZABETH PLANTAGENET**, widow of John, Earl of Holland, who *m.*, secondly, 1306, Humphrey de Bohun, fourth Earl of Hereford and Essex ; Lord High Constable of England, and had by him :

3.—**LADY ELEANOR DE BOHUN**, who *m.* James Butler, second Earl of Carrick, created, 1328, Earl of Ormond, and had :

4.—**JAMES BUTLER**, second Earl of Ormond, Lord Justice of Ireland, *b.* 1331, *d.* 1382. He *m.* Lady Elizabeth, daughter of Sir John D'Arcy, Knt., created Lord D'Arcy, of Nocton, Chief Justice and Governor of Ireland, and his second wife, Lady Joan de Burgh, widow of Thomas, second Earl of Kildare, daughter of Richard, Earl of Ulster, who was a descendant of King Louis VII., of France, through the marriage of the Princess Agnes, his daughter, with Andelm de Burgh, ancestor of the Earls of Ulster. (See Pedigree VIII.) James, Earl of Ormond, had by Lady Elizabeth :

5.—**JAMES BUTLER**, third Earl of Ormond, and Earl of Gowran, who, dying in 1405, had, by Lady Anne, his wife, daughter of John, Lord Welles :

6.—**SIR RICHARD BUTLER**, Knt., of Polestown, County Kilkenny, Ireland, who had by Lady Catherine, his wife, daughter of Gildas O'Riley, Lord of County Caven, Ireland :

7.—**SIR PIERCE BUTLER**, Knt., who succeeded, in 1516, as eighth Earl of Ormond ; Lord High Treasurer of Ireland in 1524 ; and in 1527 was created Earl of Ossory. He *m.*, 1485, Lady Margaret Fitzgerald, daughter of Gerald, eighth Earl of Kildare, and had :

8.—**JAMES BUTLER**, ninth Earl of Ormond, and Viscount Thurles ; constituted, in 1533, Lord High Treasurer of Ireland for life ; Admiral of the Kingdom. He was poisoned in 1546, leaving issue by Lady Joan Fitzgerald, his wife, daughter of James, eleventh Earl of Desmond :

9.—**THE HONORABLE JOHN BUTLER**, of Kilcash, *d.* 1570, who *m.* Lady Catherine, daughter of Cormac MacCarthy-Reagh, and had :

10.—**SIR WALTER BUTLER**, of Kilcash, who succeeded as eleventh Earl of Ormond, and, dying in 1632, had by Lady Helena Butler, *d.* 1631, his wife, daughter of Edmund, second Viscount Montgarret :

11.—LADY MARGARET BUTLER (sister to Thomas, Lord Thurles, father of James Butler, created Duke of Ormond), who m. Bryan Fitz-Patrick, fifth Lord of Upper Ossory, and had :

12.—EDWARD BRYAN, Esq., of Westminster, London, second son, who dropped his right surname, Fitz-Patrick, and assumed that of Bryan, and whose daughter :

13.—ANNE BUTLER BRYAN, m., 1724, Major-General Alexander Spotswood, b. 1676, also of Royal Descent. (See Pedigree XXIX.) He served with distinction under the Duke of Marlborough, and in 1710 was appointed Governor of the Virginia Colony, and in 1739 Deputy Postmaster-General for the Colonies. He resided at "Porto Bello," near Williamsburg, Va., and at what is now known as the "Moore House," which he built on "Temple Farm," near Yorktown, Va.. On the eve of embarking at the head of an expedition fitted out against Carthegena, he died at Annapolis, Md., 7 June, 1740, having issue by Anne Bryan, who remarried Rev. John Thompson, of Culpeper County, Va. :

14.—ANNE CATHERINE SPOTTSWOOD, who m. Colonel Bernard Moore, of "Chelsea," King William County, Va., and had : ALEXANDER S. MOORE (see Pedigree XXIX.) and :

15.—ANNE BUTLER MOORE, who m., as his second wife, Charles Carter, of Shirley and Corotoman, on the James, Virginia, d. 1770, aged 34, a descendant of John Carter, d. 1669, who settled in Nansemon County, Va., and was a member of the Virginia House of Burgesses, 1649-54, and Commander-in-Chief of the Virginia Colony troops, and had :

16.—ANNE HILL CARTER, b. 1771, d. 1829 ; m., 18 July, 1793, as his second wife, Major-General Henry Lee, b. January, 1756, d. March, 1818. He was the celebrated "Light-Horse Harry," of the Continental Army, a member of the Continental Congress, and thrice Governor of the State of Virginia. Issue :

1.—CHARLES CARTER LEE, of Powhatan, Va., d. 1871 ; m. a daughter of George Taylor, and had : GEORGE.

2.—COMMODORE SIDNEY SMITH LEE, b. 1802, d. 1869. He was a Commander in the United States Navy, and at the breaking out of the Civil War resigned this commission and accepted that of Captain in the Confederate States Navy. He m. Anna M., daughter of General John Mason, of "Clermont," Fairfax County, Va., and granddaughter of George Mason, of "Gunston Hall," Va., and had :

I.—GENERAL FITZHUGH LEE, of "Richlands," Stafford County, Va., eldest son, Major-General, C. S. Army, and at the time of the surrender of his uncle, at Appomattox, 9 April, 1865, he commanded the cavalry corps of the "Army of Northern Virginia." General Lee was subsequently Governor of Virginia, and m., 19 April, 1871,

3.—GENERAL ROBERT EDWARD LEE, *b.* 19 January, 1807, *d.* 12 October, 1872, Commander-in-Chief of the Armies of the Confederate States. He *m.*, 30 June, 1831, Mary Randolph, only daughter of George Washington Parke Custis, of "Arlington," Alexandria, Va., also of Royal Descent, and had :
