## Biography

When **Clarkey Parker** was born on **November 8, 1754**, in Pasquotank, North Carolina, **her father, Elisha, was 25, and her mother, Elizabeth, was 18**. She married Thomas Henby on September 1, 1773, in Perquimans, North Carolina. They had six children. She died in 1810 at the age of 56.
