FAMILY HISTORY NOTE FROM: "History of Perquimans County, North Carolina" by Mrs. Watson Winslow, page 334: Timothy Clare was a Quaker and wielded a strong influence in the county (Perquimans County, North Carolina) for the betterment of settlers, and the usefulness of its citizens. He owned large bodies of land in Perquimans County, North Carolina. Numerous deed transfers, and his will (stated below) indicate that he was probably quite wealthy. Numerous entries in Footnote 3, attest to the fact that he was a trusted and loyal Quaker.

WILL OF TIMOTHY CLEARY (CLARE): ("History of Perquimans County, North Carolina", by Mrs. Watson Winslow,) Page 136: "Sick & weak of body, but sound of mind, and memory do make this my last will, in manner as follows: to wife Hannah, what was hers before I married her, one Negro man named Sibbie, household goods & furniture. To Daughter, Mary Mayo, 200 acres, whereon I now live, the upper part thereof, where J. Perry lives, and 200 acres next to John Winslow. To John Winslow, plantation, whereon his father and mother now live, after their decease. to son-in-law Thomas Winslow, 154 acres in Long Branch. To his two sons, Timothy and Jesse, part of tract, adjoining their father. To Elizabeth Winslow, land back of John Winslow. To daughter Jane Jessop and husband, Thomas, plantation in Old Neck bought of my brother-in-law, William Budny (brother of his first wife, Mary Bundy). To daughter, Sarah White, plantation whereon she now lives, on ye creek, and a tract on the River called "passing Hall". To daughter Hepzibah Perry, (thought to be step-daughter,) land formerly Simpsons, 200 acres where on she now lives. To daughter Hannah (by third wife) plantation on Vosses Creek, on lower side of same, 200 acres bought of Thomas Harvey, and 130 acres at "Snodens dock." To daughter Jane, & son-in-law Thomas Jessop, 100 acres adjoining Stephen Gibson. To grandson, John Robinson, 200 acres on Mill Creek. To each daughter a Negro, "ye Meeting to value same out of remaining Estate." My five children: Mary, Elizabeth, Jane, Sarah, & Hannah. Grandson and granddaughter, John and Sarah Robinson, 20 pounds. To Grandson, Thomas Winslow, my beaver hat. Executors: Sons-in-law, Thomas Winslow and Thomas Jessop. Probated 11/10/1724, before E. Mosely. Attest: Thomas Bagley, Smith Cale.
