John, S29970, MA Line, sol lived at Truro MA & at Gorham MA (ME) during the Rev, appl 31 Aug 1832 at Gorham in Cumberland Co ME where he had lived since 1779, sol was b 17 May 1757 at Truro MA
Jonathan, Azenath or Asenath, W15041, MA Line, sol appl 2 Jun 1818 Hampden Co MA, in 1820 sol was aged 59 with a wife & 2 children; Asenath 36 & Justin 17 at home, wid appl 1 Jan 1839 Hampden Co MA aged 73, the sol Jonathan Lombard, Jr. of Ludlow MA m Asenath Olds of Belchertown MA on 3 Jun 1784, sol d 28 Oct 1838, sol's son Justin Lombard of Ludlow MA made aff'dt in 1828 aged 26 on 8 Mar 1828

Stephen, S13783, MA Line, appl 16 Jul 1832 at Aurelius in Cayuga Co NY aged 69 yrs 10 mths, sol's bro Stephen Lombard made aff'dt 27 Nov 1832 a res of Galen NY & had also rec'd a Rev War pension
Thomas, Hannah, W24586, BLW #17861-160-55, MA Line, sol lived at Truro in Barnstable Co MA at enl, he appl 17 Sep 1832 Oxford Co ME aged 70, wid appl 22 Jul 1843 Oxford Co ME aged 76, sol m in Dec 1768 to Hannah Linnell & sol d 1 Jan 1836, wid appl for BLW 7 Apr 1855 at Oxford ME, wid d 3 Sep 1856
Thomas, Hannah, W24589, MA Line, sol m on 23 Jan 1783 to Hannah Burrinton of Bowdoinham in Lincoln Co MA (ME) & sol appl there 2 Jan 1833, sol was b in 1761 at Bath MA (ME) & he lived there at enl & later moved to Minot MA (ME) for 9 yrs & about 1813 he moved to Bowdoinham MA (ME) & his wid appl there 4 Apr 1839 aged about 75, sol d 29 Dec 1834 at Bowdoinham ME

- LONASS**, John, Mary Fardin or Farden former wid, W19252, Cont Line (MD), wid appl 27 Nov 1837 Morgan Co VA aged 77 on 15 Aug 1837, sol had enl at Fredericktown MD (he lived in Frederick Co MD) & srv in the German Regt, sol & wid had m in Feb 1779 & they had a son John Lonass, Jr. born 15 mths after they were m (he was b 31 May 1781) & wid stated in 1837 "if still living he resides in OH", sol died while in srv & wid m 2nd to Aaron Fardin & they moved from MD to Berkeley Co VA the part that became Jefferson Co VA & the said Aaron Fardin d 21 Feb 1834, family records; Joseph Farding b 9 Feb 1778, James Harrison b 25 Dec 1761
- LONDON**, Charles, BLW #6095-100-23 Aug 1790, srv as a Pvt in the CT Line, a BLW with the same #6095 was issued to Lee Hall exc'r of Samuel Hall for CT Line srv on 16 Mar 1792

- LONG**, Adam, R6421, NY Line, appl 2 Feb 1838 Albany Co NY aged 75 a res of New Scotland NY
Alexander, S22365, PA Line, sol was b in 1756 in Chester Co PA & he lived there at enl & in 1791 he moved to Allegheny Co PA & in 1807 he moved to Beaver Co PA & he appl there 8 Mar 1834
- Anderson**, S17549, NC & VA Line, appl 13 Nov 1832 Marion Co MO, sol was b in 1763 in Culpeper Co VA & he lived there at enl & srv with a Lt Reubin Long, after the Rev he lived in VA then lived in Warren & Mercer Cos KY then moved to Marion Co MO
- Andrew, Susan, W3147, PA Line, sol m Susan Miller 20 Dec 1775 at Lancaster PA & sol d 2 Mar 1804, wid appl 24 May 1844 Lancaster Co PA aged 87, sol had lived in Lancaster Co PA at enl
Andrew, Jemima, W8063, BLW #40504-160-55, PA Line, sol was b in 1758 in Bucks Co PA & he lived there at enl & later moved to Fayette Co PA then moved to Union Co IN where he lived when he appl 9 Sep 1832 in Bucks Co PA, sol's mentions a John Long living in his neighborhood, wid appl 2 Jul 1855 in Mercer Co IL aged 78, sol m Jemima Santee on 18 Oct 1794, sol d 16 Nov 1835, wid appl for BLW in 1855 in Mercer Co IL
- Benjamin, S8851, NC Line, sol was b 8 Oct 1759 in Orange Co NC & he lived in Caswell Co NC at enl & also srv as a sub for a John Long (relationship not stated), after the Rev sol continued to live in Caswell Co NC except for a few mths in Pittsylvania Co VA, sol m sometime in May the yr of Gates' defeat at Camden (wife wasn't named), he appl 5 Nov 1833 Caswell Co NC & he had also married there

- LONG, Benjamin, S40101, PA Line, sol enl at Lebanon PA, he appl 21 Oct 1818 Franklin Co PA, on 13 Mar 1827 sol gave his age as 69 yrs 8 mths, sol named the following creditors in 1827; Nicholas Blac, Martin Myers, John Creamer & Philip Laufman all of Franklin Co PA, James Grimes, Wm. Harkness & Wm. Greacy of Cumberland Co PA, James Means, Wm. Wilson, Hannah Shearer & Catherine Tice of Franklin Co Benjamin, S8846, VA Line, sol was b in 1763 in Caroline Co VA (his sis in "Hanover" had the family records) & he lived there at enl & also appl there 10 Sep 1832, Jas Bradley & Jno Carter were wit's Benjamin, S32383, VA Line, sol was b in 1761 in Frederick Co VA about 4 mile from Winchester VA & he lived in Hampshire Co VA at enl & after the Rev he lived in Westmoreland Co PA then moved to Mason Co KY then to Brown Co OH then to Crawford Co IL & he appl there in Jun 1835
- Daniel, S13773, VA Line, sol appl 26 Oct 1833 Madison Co AL, sol was b 11 Apr 1756 in Culpeper Co VA, sol enl with one Armistead Long (relationship not stated) in Culpeper Co VA, sol's wid Martha Long of Madison Co AL made aff'dt 4 May 1839 & stated sol d 11 May 1838
- David, S23304, MA Line, sol was b 10 Aug 1761 at Hopkinton in Middlesex Co MA & he lived there at enl & after the Rev he lived at Wilmington VT for 2 yrs then moved Hebron in Washington NY for 26 yrs & in 1810 he moved to Pembroke (now called Darien) in Genesee Co NY & he appl there 16 Oct 1832
- David, Mary, W#2, NC & SC Line, sol was b in 1758 in Bedford Co VA & he lived in Rowan Co NC at enl, sol appl 12 Sep 1832 Maury Co TN & sol d 24 Jan 1845 in Marshall Co TN, sol had m Mary Howe 28 Jun 1787 in York Co SC & she appl 4 Jul 1850 Marshall Co TN aged 62, children were; Catsey b in Feb 1788 David b 17 Nov 1789, Margret b 8 Dec 1790, Mary b in Apr 1793, Martha b 17 Nov 1796, Joseph b 5 Dec 1797, Jannot b in Feb 1800, Rebecca b in Mar 1802, Esther b 24 Jun 180? & Elisebeth b 29 Apr 1807
- Eliel, S22884, PA Line, sol was b 9 Aug 1756 in Queen Anne Co MD & he lived in Greene Co PA at enl & he appl there 17 Sep 1833, sol d 13 Jan 1835
- Enoch, Molly, W16138, MA & NH Line, sol m Molly Kimball 22 Jan 1784 both were of Hopkinton in Merrimack Co NH, a son Isaac Long made aff'dt at Hopkinton NH on 30 Apr 1840 aged 51 & stated sol d 16 Jan 1817 & his mother Molly was living with him when she appl 3 Apr 1840 at Hopkinton NH aged 76
- Gasper, S7161, NC Line, sol was b in Aug 1763 in PA & when a small boy was moved to Orange Co NC & he lived there at enl & he also appl there 11 Mar 1833, a Samuel L. Holt was a witness
- George, S18087, Navy Srv, NH Line & NH Sea Srv, vet was a son of Col Kiva Long who commanded the 1st NH Regt & was of Portsmouth NH where he enl & he also appl there (exact date not given)
- George, BLW #8482-100-14 Feb 1791 assignee Alexander Power, srv as a Pvt in the NJ Line
- George, Isabel, W9139, BLW #26619-160-55, PA Line, sol was b about 1763 in Cumberland Co PA & he was living at Muncytown PA at enl & he moved with his father (not named) to near Winchester VA & also enl there in 1781, sol's father d at the "falling springs" of the Potomac prior to 1798, sol appl 3 Sep 1833 Warren Co PA, sol m Isabel McCormick in Aug 1792 in Lycoming Co PA, sol d 11 Mar 1854 in Warren Co PA & his wid appl there 11 May 1854 aged 78, wid d in the fall of 1858, sol & wife raised a large family of children but no names were given in the claim
- George, S4564, VA Line, appl 3 Apr 1833 Hawkins Co TN aged 75, sol was b in 1757 or 1758 in Shenandoah Co VA & he lived there at enl & after the Rev he lived in VA then moved to TN
- Gideon, Hannah, W3270, PA Line, sol was in 1754 in Queen Anne Co MD & he lived in Washington Co the part that became Greene Co PA at enl & he appl there 16 Apr 1833, sol m 21 Mar 1781 to Hannah (--) in Washington Co PA, wid appl 22 Feb 1839 Greene Co PA age 78, they raised a large family (no names)
- Henry, R6427, NC Line, on 20 Apr 1852 sol's youngest child Henry Long made aff'dt in Troup Co GA aged 55 & stated sol was b 25 Apr 1756 & d 7 Oct 1824 leaving a wid Ann who was b 21 Dec 1761 & she d 13 Oct 1828, sol's oldest son John Long made aff'dt in Franklin Co NC on 11 Apr 1854 & stated he was aged 61 on 7 Apr 1854 & referred to his father as formerly of Hancock Co GA & sol had lived in Bute the part that is now in Halifax Co NC at enl
- Henry, S1849, VA Line, sol was b in Culpeper Co VA & he lived there at enl, appl 25 Apr 1833 Greene Co TN aged 69 being b on 30 May 1766, sol's wid (not named) rec'd final payment on 14 Jan 1839 & was paid to 4 Mar 1838
- Jacob, Mary, W3434, BLW #26186-160-55, PA Line, sol m Miss Mary Grimler at Lancaster PA on 22 May 1785, sol appl 20 Aug 1832 Lancaster Co PA & he lived there at enl, sol was b in 1759, wid appl 14 Aug 1845 Lancaster Co PA aged 82, sol d 6 Dec 1842, wid appl for BLW in Apr 1855, wid d 26 Dec 1855
- Jacob, Eve, W1790, BLW #26907-160-55, PA & VA Line, sol was b in Chester Co PA & lived in Berks Co PA at enl & afterwards moved to Frederick Co VA for 2 yrs then moved to Loudoun Co VA & he appl there 19 Nov 1832 aged 78, sol m Eve Funk in Sep 1794 in Loudoun Co VA & he d 22 Dec 1842 & his wid appl 7 Oct 1848 in Loudoun Co VA aged 70
- James, R6428, NC Line & NC Sea Srv, vet was b in Tyrell Co NC & he lived there at enl then moved to Washington Co NC & he appl there 10 Mar 1836 aged about 80
- James, Margery, W9509, SC Line, sol lived in Abbeville Dist SC at enl & sol m there to Margery Thomas or Thompson in Sep 1775, sol d 6 Apr 1825 in Anderson Dist SC & his wid appl there 19 Feb 1846 aged 88 & she d there 13 Mar 1846 leaving children; Ezekiel & William Long, Anna wife of James Herron, Margery wife of David Gorterry or Gorteny all of Anderson Dist SC, Matthew Long of Hall Co GA, Mary wid of George Tippen of Cherokee Co GA, John A. Long of Jackson Co GA & George Long of Henry Co GA, children's births were; Elizabeth b 25 Jul 1777, Matthew b 29 Dec 1780, Mary b 14 May 1782, James b 16 Apr 1785, Henry & John Anderson b 22 Aug 1787, Ann or Anna b 28 Mar 1790, there were no birth dates for William, George & Margery
- Job, BLW #4563-100-7 Aug 1789 to Peter Anspach, srv as a Pvt in the MA Line
- John, Mary, W5029, Cont & VA Line, sol appl 25 Aug 1825 Edgecombe Co NC aged 75 & sol d there 11 Oct 1826, sol had m Mary "Polly" Armstrong about 1783 in Sussex Co VA & they lived there some 10 yrs after they were m then moved to Edgecombe Co NC with her father & family (no names given) & about 3 after moving there her father died, wid appl 22 Aug 1842 Edgecombe Co NC aged about 80, in 1825 sol had a daughter aged 17 & 2 grandchildren; a boy aged 17 & a girl aged 14 were living with him but no names were given, in 1841 a Robert Long was of Tarboro NC & a Wm. L. Armstrong was a JP for Edgecomb Co NC in 1845 but their relationship to sol's family wasn't given
- John, BLW #11445-100-17 Jul 1797 assignee Abr'm Jarritt, srv as a Pvt in the MD Line

- LONG, John, Nancy, W9508, MD Line, sol lived in Harford Co MD at enl & he m there to Ann or Nancy Scott in Feb 1779 (license issued 21 Feb 1779), sol d 29 Aug 1819 in Harford Co MD & his wid appl 23 Jan 1839 aged 86, sol's bro Luke Long of Harford Co MD aged 78 made aff'dt in 1839
- John, Esther, W3569, MA Line, sol lived at Medway in Norfolk Co MA in early 1775 & late in 1775 he moved to Shelburne MA & was a "highly esteemed physician & surgeon" & he lived he d in Shelburne MA on 24 Jan 1805, sol had m at Medway MA to Miss Esther Haws on 14 Sep 1775, wid appl 1 Sep 1837 at Shelburne in Franklin Co MA & on 5 Feb 1844 she gave her age as 91, wid d 3 May 1844, sol & wife raised a family of children & those who survived the sol were; Silas, Esther, Diana & Betsey but only Ester & Silas survived their mother & Ester d 4 Aug 1849, in 1851 Dr. Silas Long was of Kane Co IL a res of Big Rock IL & had been practicing medicine for 50 yrs & on 16 Nov 1853 he gave his age as 73 on "this day"
- John, Frances, R6426, NC Line, sol appl 3 Dec 1832 Madison Co IL aged 70, sol enl in Granville Co NC & sol stated he was either born there or his parents moved there before he could remember & he lived there for 3 yrs after the Rev then moved to Caswell Co NC for 8 or 10 yrs then moved to Logan Co KY & in 1822 he moved to Madison Co IL, wid appl 2 Mar 1840 St Clair Co IL aged 79, sol m Frances Estes in Feb 1791 & sol d 10 Feb 1839, a son John Long made aff'dt 4 May 1857 in Cass Co IL aged 55 & he stated wid d about 1844 & in 1857 the son John Long was the only surviving child
- John, R6429, NC Line, appl 21 Mar 1843 Person Co NC aged 79 & he had lived there at enl, sol's bros James Long aged 74 & Jesse Long aged 72 of Person Co NC made aff'dt 23 Mar 1843 & they stated their father (not named) hired one Benjamin Long as a sub for their bro John Long's 2nd tour
- John, S25233, VA Line, sol appl for an increase in pension on 27 Feb 1817 at Fredericksburg VA
- John, S36047, VA Line, sol enl in Orange Co VA, appl 22 Jul 1819 Franklin Co KY aged 68
- John, Amy, W3433, VA Line, sol's bro Benjamin Long made aff'dt 3 Sep 1840 in Caroline Co VA & sol had lived in Caroline Co VA at enl & he had m there to Amey Gatewood about 1782 & sol d 9 Jun 1792, children were; James b 27 Oct 1783, Reuben b 12 Sep 1785 & he m Patsey (Landrum) who was b 5 Oct 1791 & their children were Gabriel R. b 2 Sep 1807, Lavinia b 11 Mar 1810, Elizabeth b 26 Apr 1813 & C. Addison L. 6 Mar 1815, the sol had children other than James & Reuben but they were not named, sol's wid appl 7 Aug 1840 Caroline Co VA aged 78
- John, Delilah, W10200, VA Line, sol was b 24 Dec 1755 & he m Delila (--) in 1780 in VA & sol d 20 May 1828 in Harrison Co IN, sol appl 7 Apr 1819 Harrison Co IN aged 65, sol enl in Loudoun Co VA, in 1821 sol had a wife Delilah aged 56 & 2 children; John 14 & Delilah aged 12, wid appl 14 Nov 1842 in Harrison Co IN aged 78
- John Phillip, S38147, PA Line, appl 3 Nov 1830 Pendleton Co VA aged 79 or 80 with no family at home
- Jonathan, Nancy, W383, MD & PA Line, sol was b 16 Oct 1758 in York Co PA & he lived in Franklin Co PA at enl & after the Rev he lived in MD, VA & TN, he appl 1 Oct 1833 Hawkins Co TN, sol m Nancy (--) in Sep or Oct 1783 in Frederick Co VA & she was b 3 Apr 1762, sol d 4 Feb 1841 in Hawkins Co TN & his wid appl there 12 Jul 1845, children were; John b 5 Jul 1784 & he m Jan 1807 & his 1st child was b 20 Nov 1809 (wife & child were not named), David b in Jun 1786, James W. b in Sep 1788, Sally b in Dec 1790, Nancy b in Aug 1797 & Mary b in Mar 1800
- Joseph, BLW #13380-100-8 Nov 1791 to Judith Long adm'x, srv as a Pvt in the Invalid Corps
- Joseph, Elizabeth, W10201, MD Line, sol was b 24 Oct 1761 & he m Elizabeth (--) 26 Oct 1784 in Frederick Co MD & she was b 23 Feb 1761, sol d 9 Jul 1827, wid appl 27 Sep 1843 Washington Co IN, children were; John b 24 Jul 1785, Jacob b 31 Mar 1788, Elisabeth b 3 Sep 1790, Sarah b 12 Feb 1793, Margrett b 12 Sep 1795, Susana b 24 Jul 1798, Nancy b 21 May 1801 & the youngest child's name was in German & was b in 1804
- Joseph, S18091, MA Line, sol lived at Chester in Rockingham Co NH at enl & he appl there 7 Aug 1832 aged 79, a Jacob Elliot, Jeremiah Richardson & William Moore were witnesses for sol
- Joseph, Phebe, W15033, BLW #4583-100-26 Aug 1790 & BLW #219-60-55, MA Line, sol d in 1798, wid appl 11 Apr 1837 Cheshire Co NH aged 78 in Aug 1836, sol m Phoebe Hill in Mar 1778, wid appl for BLW on 6 Jun 1855 Cheshire Co NH & a Joseph Long & Elijah Carpenter were witnesses to her 1855 aff'dt
- Joseph, Christina, W2137, PA Line, sol appl 25 Sep 1832 Union Co PA aged 75, sol lived in Philadelphia Co the part that is now Montgomery Co PA at enl & he was b there 15 Jun 1757 & some 25 to 30 yrs prior to 1832 he moved to Northumberland Co the part that is now Union Co PA, there were six children's births shown in German dated 1790, 1792, 1794, 1799, 1801 & 1805, a son Joseph Long made aff'dt 16 Sep 1851 in Union Co PA aged 51 & stated wid had d 3 Feb 1849 leaving children; Sarah Ranch, Jacob, John & Joseph Long, wid had appl 4 Dec 1846 Union Co PA aged 76, sol & wid had m when she was age or 18 yrs, sol d 11 Jan 1835
- Josiah, Mary Smith former wid, R9801, MA Line, sol m Mary "Molly" Cole 16 Apr 1789 & both were of Biddeford in York Co MA (ME), in 1844 a Jacob K. Cole was a JP for York Co ME but no relationship to wid was stated, a daughter Sarah Poole made aff'dt 9 Nov 1844 & stated sol lived at Andover MA at the start of the Rev, sol also srv as a sub for his bro Joshua Long, sol d 13 Jun 1832 & wid m 2nd to Samuel Smith on 2 Nov 1835 & he d 3 Apr 1839, wid d 5 Aug 1843 leaving children; Sarah Poole, Elijah & Nathaniel Long & Maria L. Bonney, wid's sis Sarah Haley of Westbrook in Cumberland Co ME was aged 64 when she made aff'dt 2 May 1844 & stated sol's & wid's oldest child was b about 2 yrs after sol & wid m & she (Sarah Haley) was aged 11 at the time the child was born
- Levi, Martha, W2138, BLW #1965-160-55, CT Line, sol was b 23 Jul 1758 at Coventry in Windham Co CT & he lived there at enl & at the end of the Rev he moved to Rutland VT & he appl there 10 Aug 1832, sol m 6 Dec 1832 to Mrs. Martha Kimball at Rutland VT & sol d 11 Sep 1849, wid appl 26 Feb 1853 at Rutland VT aged 79, in 1853 Luman C. Long & Ira Bliss were witnesses for widow
