 I Impremitt it is my Will and I Do order that in the first place
 all my just Debts and Liabilities be paid and Satisfied
 Then I Give and bequeath unto my Will beloved Son Nathaniel Core the
 Land & plantation he now lives on all on the Eastward Side of the main
 branch to the Division Line between my plantation Theron's & Nath-
 lios and his Beginning at A Small Rise in and then the of Small
 Branch called the Poplar Branch Joining Benjamin Plindys Line
 thence A West Course to A Small Grove of Oaks in A Small
 Branch running in the Old field between my field fence and his

thence West to a small Oak in the Old Field thence West to a short
pine at the Edge of the Old field thence South Course to tall Marked Pine
at the above Mentioned Trees being Marked Along a line of Marked trees
to a hollow thence down the said bottom to the lower called Mark to him
and his heirs forever

the Mare Bounded thus N. E. and Lohewia all the Cattle that my
my proper that is called Longs to him they and their heirs forever
him and his heirs forever

Then I Give unto my son William Come the Remaining Part of my
Land lying on the South side of the New Branch the Land and
Plantation he has been in to him and his heirs forever Likewise A
fewther Bed and Furniture to him and his heirs for ever

Then I Give unto my Daughter Sarah Jesse a Cow and thirty Shillings
to be Received paid out of my Estate to her and her heirs for ever

Then I Give unto my Daughter Mary Harrell a Cow and Calf or thirty
Shillings to be Received paid out of my Estate to her and her heirs forever

Then I Give to my Daughter Rebecca Joseph a Cow and Calf or thirty Shillings
to be Received paid out of my Estate to her and her heirs for ever

Then I Give to my Daughter Martha Chooey a Cow and Calf or thirty
Shillings to be Received paid out of my Estate to her and her heirs
for ever

I Give to my Daughter Charity Come a Cow and Calf and all the
Residue of my Movable Estate to be Equally Divided between the said my two
sons Jesse and Come them and their heirs for ever

I Likewise Make Confess that I have made and full that I have made and
Execute my last my William Come and Jesse Come of this my last
Will & Testament and Do deny all Other Wills and Testaments before
me Named Will or bequeathed Relieving and Confirming this and that to
be my last Will & Testament the Day and year above Written and my
hand Signed sealed Delivered and pronounced and Declared
by the said Nath Come to be his last Will & Testament
