INTRODUCTION

I am pleased to issue a first volume of deed abstracts for Tyrrell County. Tyrrell is one of North Carolina's oldest counties. It was formed in 1729. At its start it included today's Martin County(1774), Washington County(1799), and a part of today's Dare County(1870).

As you read through the deeds you will discover that the word "county" gradually replaced the older word "precinct."

While the county dates back to 1729, the deeds begin in 1735. Bear in mind that we are looking at the probate dates when dating a deed. I recall one deed probated or registered in 1735, and numerous deeds probated in 1736. What happened to the earliest deeds? At this time, we do not know. Mr. George Stevenson of the North Carolina State Archives has not given up: They may yet appear mixed in with an adjacent county or precinct IF the residents went to another court to register their lands.

Please note that the deeds do not follow a "good" chronological order by probate date. They appear to have been "stirred around." You will even find several which were probated as late as 1770 even though I have given 1760 as the terminal year in this work. Many of the deeds actually pre-date 1735 but were not registered until later.

One point to keep in mind is that we do not have the original deed books. Many counties did as Tyrrell County did: At some point the records were copied into new books. You will find the date 1829 at certain points as an examination date for the copying of the records.

AS ANY AND EVERY ABSTRACTOR WARNS: When you find what you are looking for, for goodness' sake, go back to the microfilm or bound volume! I am, at most, human. Look over my shoulder and make sure I read it correctly! My purpose for an abstract is to open the original. The only alternative is to read the entire original book, page by page.

My system for abstracting is a simple one, following in most cases, the order of the deeds themselves:

Grantor, occupation, place
Grantee, occupation, place
Date of Deed
Price
Amount of Land
History of Land
Bounds of Land
Signatures
Witnesses
Probate Date [Note: When probate date not given, registration date is used]
Clerk of Court/Register of Deeds

It has not always been feasible to follow slavishly this order. Any other information was included. While much that will tell of social history is here and can be gleaned from the abstracts, always remember that I extract primarily for genealogical purposes. There is always the possibility—a very real one—

that I missed something or overlooked a name embedded in bounds or encased in ritual language. But I tried to find all the names.

The indexes are, first, a full personal name index; then, a geographical and other index(which includes certain miscellaneous items--run through it); and finally, an index to slaves.

I assigned a number to each deed, which runs a numerical sequence through this volume, and the deed is indexed by this assigned number. The numbers in parentheses are the page numbers on which the deeds begin. The consultation of the original is expedited.
