«b»Benjamin Hubbard«/b» (c.1715-1771) was a resident of Prince George County when got 400 acres on the upper side of Flat Creek in present-day Amelia County 1 August 1734, and added 490 acres 13 October 1736. Benjamin paid tithes in Amelia County from its inception in 1736. Benjamin married first Alice Hendrick, a daughter of Adolphus Hendrick whose 1762-will in Cumberland County left £10 pounds to daughter Alice Hubbard. For "love and affection for his brother,"

Benjamin gave Joseph Hubbard 140 acres out of his 890 acres on the north side of Flat Creek 21 November 1740. On 17 May 1743 when Benjamin deeded 350 of these acres to «u»Thomas Tabb «/u» of Raleigh Parish for £35.8, Alice, his wife relinquished her dower. Benjamin Hubbard purchased 70 acres on the upper side of Flat Creek from «u»William Booker «/u» and Mary, his wife, 16 February 1757. «u»Edmund Booker «/u» sold him 28 acres on the south side of Flat Creek 26 January 1758. No wife relinquished dower when Benjamin sold a tract on Haw Branch to «u»Joseph Collins «/u» 19 September 1743.

Benjamin secured a patent to 800 acres in present-day Halifax County 3 November 1750. He was an illiterate Benjamin Hubbard of Halifax County when he sold 470 acres in Amelia County to Thomas Atkinson 3 November 1757. Halifax County taxed Hubbard on 1,200 acres in 1755. The name of Benjamin Hubbard appears in the records of the South River Monthly Meeting from 1758 to 1763. Alice was with him in 1759, but was dead by 1763 when Benjamin was ordered disowned for marrying out of union, apparently Hannah Martin, the daughter of Isaac Martin, who identified a daughter as "Hannah, wife of Benjamin Hubbard" in his 1769-will in Halifax County. «u»Benjamin Dickson «/u» sold Hubbard 892 acres on the north side of the Banister River 21 February 1760 and another 285 acres 6 February 1764. In 1765 Benjamin and Hannah sold 101 acres that had been granted to Abraham Echols in 1748 to John Rowden. «u»Joseph Collins «/u» and two men named Isaac Martin witnessed the deed. Elijah Merry Bailey sold 200 acres on the north side of the Banister River to Benjamin Hubbard 10 September 1770. Benjamin wrote his will 13 October 1770. He must have died soon afterwards for his will was proved in Halifax County 21 March 1771. His children were the ones identified below. His wife, Hannah, was still living. An inventory of Benjamin's personal estate, recorded April 1772, included some household goods, plantation tools, a large Bible and a "Negro man, Sam." Value was £227.19.5. Other property mentioned in the will was a horse named "Prince" and some cattle. Benjamin had sufficient land to divide among all eight children. The personal estate was liquidated for about £274 and distributed to the seven youngest children. He excluded Joel. In December 1772 each

received about £36, except Nathaniel who received £20 more as directed by his father. Names mentioned in the sale of assets included «u»John Carr «/u», «u»Benjamin Abbott «/u», and «u»John Sparrow «/u». Joel Hubbard and Moses Hendrick, Alice Hendrick's brother, the executors, sold about 46 acres to Joseph Street, 100 acres to «u»John Adams «/u», and about 173 acres to «u»William Gillintine «/u» in 1777. On 23 April 1778 Robert Farguson Hubbard was a ward of the parish in Amelia County. He was the illegitimate child of Ann Hubbard. Hannah delivered guardian accounts for Benjamin, Hannah, and Rebecca 1773-79

21 Mar 1771 Probate: Benjamin Hubbard, late of Halifax County, Decd. Last Will & Testament of Decedent presented by «b»Moses Hendrick «/b»and Joel Hubbard, executors named therein, proved by two witnesses, and ordered recorded. The said «b»Moses «/b»having affirmed, and the said Joel having taken oath, they were confirmed as Executors, with Benjamin Dixon and William Echols, Jr., as their securities. («i» Halifax County, VA, Wills «/i»O:302; «i» Court Orders«/i», 7:76) «i» Alice, daughter of Adolphus Hendrick, was married to Benjamin Hubbard. There were several Benjamin Hubbards in Caroline, one of whom was a wealthy merchant, a magistrate, and a Quaker. Just where this Benjamin«/i» «i»Hubbard fitted into that family is not clear, but the family allegedly originated in Pennsylvania. Considering the executors and the presence of the Echols, this Benjamin was a Quaker. Moses Hendrick was the Decedent's brother-in-law.«/i»

Halifax Co., VA Will Book 0, pg. 300 (Transcribed by Wanda Brooks)
Dated 13 Oct. 1770

13 Oct 1770 Will: Benjamin Hubbard of Halifax County “being sick & weak but of perfect mind and memory”. Summary: To son Joel Hubbard the 400 acres “whereon I now live”, except for a portion “above the edge of the old mill pond” devised to daughter Judith Hubbard. To daughters “Sary” and “Drusylla”, the lower and upper halves, respectively, of “my back survey”. To son Benjamin Hubbard, part of “the land I first bought of Benjamin Dickson”. “My wife Hannah” to have a privilege on said place during her widowhood. To daughters Hannah and Rebecca the land “I last purchased from Benjamin Dickson”. To son Nathaniel Hubbard the land “lying on the Bannister River that I bought of Elijah? Bailey.” Lend to wife Hannah my negro Sam for ten years unless she marries, and at the end of ten years Sam to be sold if he chooses otherwise I give him to son Benjamin. Also lend to wife Hannah my horse Prince and ten head of cattle and one sow and shoats during the time of her widowhood “and no more”. “All my household goods... I leave to the use of my family. The rest to be divided amongst my six? children...” The will further specifies that a piece of land on Childrey Creek be sold and debts collected and the resulting money be “divided equally amongst my seven youngest children, only my son Nathaniel to have 20

pounds more than the rest of them.” Executors: Moses Hendrick and Joel Hubbard. Witness: James Bailey Sr., James Bailey Jr. Proved 21 March 1771 (see that date below) [Halifax County Will Book O, pp300]

To son Joel Hubbard & his heirs all the 400 acres of land whereon I now live except what lies above the old mill pond, also my copper kittle.

To daughter Judith Hubbard all that piece of land that lies above the old mill pond to a line between me & Benjamin Dickson to the river & thence to the mill & 1 bed & furniture.

To daughter Sary, the lower part of my back survey

To daughter Drusylla Hubbard the upper half of sd survey & a bed & furniture.

To son Benjamin Hubbard part of land bought of Benjamin Dickson beginning at the new rode where it crosses the yallow bank creek to Fountains line.

To wife Hannah a priviledge without any interruption on the sd place during her widowhood where she will & one bed & furniture.

To son Beniana (sic) one bed & furniture.

To daughter Hannah the land I last purchased of Benjamin Dickson except what lies over the Yallow Bank Creek

To daughter Rebeca the remainder of sd land.

To son Nathaniel the land lying on Banister River I bought of Eligamary Baly.

I lend to wife Hannah my negro Sam for ten years except she marryes & at end of ten years he be sold if he chooses it & if not I give him to son Benjamin. Also lend to my wife my horse Prince & ten head of cattle which she may choose & one sow & shotes during her widowhood & no more, & all household goods except working tools. The rest I leave to use of my family to be equally divided amongst my six children. Land lying on Childry Creek & wagon to be sold & money due me to be collected & all to be divided equally amongst my seven youngest children, only son Nathaniel to have 20 pounds more than the rest. My copper kittle which I have purchased I lend to wife Hannah during widowhood. If any children dy without heirs let their part be sold & equally divided among the rest.

The said Moses having affirmed, and the said Joel having taken oath, they were confirmed as Executors, with Benjamin Dixon and William Echols, Jr., as their securities.
