COMES (Combs), EBENEZER COMBS, Trumbull Co.

Butler's Hist of Youngstown, Vol 3, p. 603 states he was an ensign of 1st Regt of Milit in 1804 and was probably a Rev soldr. D Aug 1812 in Brookfield leaving wf. Mary Ann and childr: Seth; Mary Ann. Rept by Hetuck chpt.

COLEMON (Colman), JOHN, Fairfield co, p 82

No pens or rec; b Germany. One son was John b Rockbridge co Va Apr 3 1797. Soldr d nr Canal Winchester (dates unknown); bur in Kramer cem 1¼ mi so of Canal Winchester in Franklin co; tombstone destroyed and inscript obliterated. Ref Old Data furnished by Mr Ed Coleman and L L Moore Americanism officer Leach Benson Post 220 American Legion Canal Winchester. Rept by Mrs W S Van Fossen Columbus chpt. Filed to open up location of service record. Note: This part of Fairfield co since 1859 has been Franklin co.

COLSON, CHRISTOPHER, Lake co, p 83

1st wf named Hannah Robinson mar 10-2-1788; had 7 chldr not named. Dvorced from 1st wf Hannah in 1804; 2nd wf Patty Brown mar 11-23-1806; chldr: Lisa 1807; — 1809; Emily 1811; Christopher 1814; Patty 1818. Soldr d 8-23-1823 Willoughby Lake co. Ref Pens Cl Mass 25437 B L Wt 1904-160-55. Data by State D A R. Mrs T R Oehlke repts a dau Lovina No 1898 Vol 2 D A R Lin (may be the missing one above).

Pvt Md Contl; pensr of Brown co O; mar Rebecca; chldr: Joshua; John; Rhese; Michael. Soldr d 1842; livd in School Dist No 1 in Washington twp in 1825. Ref Will bk Vol 2 p 86-87 Probate Court Brown co O. Rept by Meryl B Markley Taliaferro chpt.

CONNER, BENJAMIN, ? co*

3rd Lieut. Rev or 1812? "Servd in late war." Rejected pens as no evidence of having been disabled whl in service. Ref Doc 31 Jan 6 1831. Rept by Blanche Rings.

CONNIE, JEREMIAH, Ashland co, p 85

Name spelled "Connie" Jeremiah listed in Va Contl 1825 in Richland co. Rept by J D.

COOK, CHAUNCEY, Erie co, p 86

Was b 1752. On pension list July 7 1832 as living in Groton twp. We find mention of the home of Chauncey Cook in Wallingford Conn. Rept by Marjorie Cherry, Sandusky.

COOK, JOSEPH, Butler co, p 86

Ref 5th Rept of N S D A R p 369; Under heading of "Ancestors of Knickerbocker chpt N Y. Mar Sarah Langdon. Ref Davis' Wallingford Conn; Ferneau's N Y I pp 271, 347, 348.

COOK, ROSWELL, Delaware co

Drummer Conn Contl Pensr 1819. Bur Oak Grove cem. (J D). Issue of "Delaware Patron," "Died Dec 19 1826 Roswell Cook ae 61 yrs formerly of Farmington Conn. Was under Lafayette." Cop by Blanche Rings Col O who repts refused a pens as not in indigent circumstances. Ref Exec Doc 31 of Jan 6 1831.

COOPER, EZEKIEL, Belmont co, p 87

One of the sixteen Rev soldr settled at Marietta Apr 7 1788. (J D).

COOPER, JOHN, Brown co, p 87

Pvt; Ensign; Sergt Pa Contl; Pensd 1832. J D.
