The Hopppers came from England, to the west Indies, then to Carolina and to Leaksville. William Came in 1752, surveying land with Shurton, Chief Surveyor of Lord Granville, who owned this part of North Carolina by grant of Charles II of England.

They first lived on Matrimony Creek, a branch of the Dan River, in N. C. and later some lived on the Smith River in Henry County. VA.. Matrimony Creek starts in Henry County, VA. and flows south into Rockingham City, NC. It empties into the Dan River near the the western city limits of Eden, NC. It was given it's name in 1728 by a member of William Byrd's surveying party, as they were establishing

the VA. -NC. border. Several small branches that flow into it along the way are known as Matrimony Creek as well. There are a LOT of Hopper's in the area.

Most researchers think that the Hoppers in this area descended from Thomas and Ann Hoper, who resided in Culpepper City, VA. in 1745, moved to Caswell county, NC. by 1777, and their son William moved to Rockingham City, NC by 1778.

Charles 7 children were Jasper; William; Charles; Zachariah; Elizabeth; Thomas and John. All of them went to California eventually, via a route through Missouri, except Zachariah, who returned to NC. from Missouri.

In a letter from Mollie Crawford to Ida Hopper Cox she said" I can remember one of Great-grandfathers(John Hopper) brothers, Uncle Tom Hopper and his wife Aunt Jennie. They used to visit us when I was quite small. I can remember being at their house once and his Negro man carrying me all over the place and showing me some pet deer they had."

All appurtances belonging to the same and all stock of every description and all household and kitchen furniture and my two Negro and the sum of \$200. My son Thomas Hopper to remain on the farm during the life of my wife.

My son Thomas \$500 and Negro boy after after the death of my wife, provided he relinquishes right to the SW 1/4 and NW 1/4 Sec 1 T49R28. After the death of my wife: Hannah McClure shall have my Negro girl. Have already given to the legates 1 of my son William Hopper,Dec., their full share except his son Ari to whom I will and bequeath \$50. Having already given my son Charles his portion.. Having given to my daughter Rebecca Patterson(Actually Peterson)her portion.

Having given my daughter Amy(Almira) Jennings her portion. To my granddau. Evaline

Johnson \$50. To the children of my daughter Lyndia Killian, Dec, the sum of \$500 to be equally devided between them. I have already given Mary(Conley) Case(Daughter of Lydia Anns first marriage) her portion. I have already given my dau. Elizabeth Jennings her portion. To my daug. Sally Young and Polly Hitchcock each the sum of \$300. To be paid after the death of my wife. Exec to sell land and devided the balance between the following names childres viz: Charles Hopper, Rebecca Patterson(actually Peterson), Kisiah(Keziah) Hitchcock, Hanna(h) McClure and Thomas Hopper.

Actually Lidia was not the only member of the family to become a Morman.

Polly and her husband Jesse Hitchcock were and Rebecca married Richard (Ziba)

Peterson(Mentioned in Morman D&C) who was one of the original Mormons to come to Jackson Co. Mo in 1831, although he seems to have left the church before they went to CA in 1848.
