KEY

NAME OF DECEASED:

The NAME OF DECEASED was used if given in the document. If name of deceased was not given, as was the case in some of the previously unindexed guardianships, the NAME OF MINOR CHILD was listed and so indicated as [child]. The intention was to include only the guardianships of minor children, but some may actually be for incapable adults.

DOCUMENT:

This column tells the KIND OF DOCUMENT - WILL, ESTATE, OR GUARDIANSHIP.

WILL means that the exact wording of the WILL is found on that page or location.

GUARDIANSHIP means that a guardianship appointment was made or some records relating to the guardianship were filed.

ESTATE means any other records that are not specifically a WILL or GUARDIANSHIP.

The ESTATE records here indexed consist of Administrator or Executor Appointments, Inventories, Sale Accounts, Extensions of Time, Litigation, Partitions of Land, Sheriff Sales, and ANY OTHER REFERENCES to Estates or Deceased Persons.

DATE WRITTEN: This is the date on the document, if given.

DATE OF PROBATE: This is the date the document was filed in Court.

LOCATION: Where the record can be found.

CT: Which COURT. This index covers records found in two separate Court House sources -- the Probate Court and the Common Pleas Court.

- P. means Probate Court.
- CP. means Common Pleas Court.

T: TYPE OF BOOK OR RECORD where the entry was found; See "Records Searched."

- A- means Administration Book.
- W- means Will Book.
- G- means Guardianship Book.
- M- means Microfilm not found in General Index.
- R- means old Record Book D.

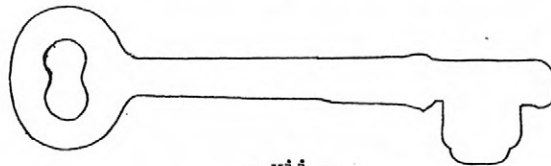
BK: BOOK or MICROFILM Roll Number or Letter Number.

PG: PAGE NUMBER or MICROFILM FILE NUMBER.
