I WILLIAM JETT of Culpeper County being of sound mind and memory do make and ordain this my last Will and Testament in the following manner Viet. Imprimis My will and desire is first of all that my just debts and funeral expences be first discharged and paid. Item It is my will that my loveing Wife SUSANNA may have full enjoyment of my whole Estate during her natural life or widowhood but it is provided in case she may after direct to be made unto them either by her death or again intermarrying. Item To my Son EDGAR JETT or his legal representative one tenth part of my aforesaid Estate but provided he may depart this life without issue it is then my will that the same shall descend to my surviving children or their legal representatives as I may here-after dispose of my aforesaid Estate. Item to my Daughter MILLY who intermarried with a certain WILLIAM JETT another tenth part of my aforesaid Estate and at her death to descend to her surviving issue or their legal respresentatives and it is my further will and desire that her said husband shall not sell or otherways dispose of any part of the aforesaid one tenth part so disposed of in any manner whatsoever to the prejudice or injury of my said Daughter Milly or her issues but on the contrary if he should attempt to do the same on their application to the Court wherein this my said last Will and Testament shall be admitted to record may take such measures as they may judge most expedient to comply with the intentions I have for the same to be used for their support and maintenance. Item Whereas my daughter MOLLY intermarried with a certain WILLIAM WILLIAMS who has since departed this life leaving issue four sons, GEORGE, URBAN, EZRA & ZEPHANIAH to whom I bequeath one tenth part of my aforesaid Estate to be divided among each of them in four equal proportions or to their legal respresentatives. Item I do hereby nominate constitute and appoint my loveing Wife Susanna Executrix and my two sons Edgar & Matthew Executors of this my last Will and Testament disannulling all other Wills ... I WILLIAM EDGAR of the County of Culpeper Planter being sick & weak in body but of perfect mind & memory do make and ordain this my last Will and Testament, that is to say, Principally and first of all I give and recommend my soul into the hands of God who gave it me and for my Body I recommend it to the Earth to be buried in a Christian like and decent

manner .. and as touching such worldly estate wherewith it hath pleased God to bestow upon me in this life I demise and dispose of the same in manner and form following Imprimis.

I give and bequeath unto my beloved Nephew SUSANNAH JETT the Wife of WILLIAM JETT one negro man named Brickee and one negro woman named Judah.

Item I give and bequeath unto my beloved God Daughter SUSANNAH MACKDONALD the wife of JOHN MACKDONALD one negro boy named Harry.

Item I give and bequeath unto MARGARET WARD the daughter of WILLIAM WARD deceased and ELIZABETH his Wife one negro boy named James.

Item I give and bequesth unto my beloved Nephew SARAH RANES the wife of ALLEN RANES one negro boy named Sam.

Item My will and desire is that the first child the said Judah that is Bequeathed unto Susannah Jett after the date of these presents to JOHN WALKER the son of EDWARD WALKER and MARY his wife.

Item My will and desire is that my houshold goods and moveable Effects and stock after my wife's decease be sold at Public Oction and the money equally between THOMAS PINER, SUSANNAH JETT, SARAH RANES, MILDRED WALKER and DAVID CORBIN divided

Item My will and desire is that my Wife SUSANNAH EDGAR be not molested but keep possess and enjoy my whole estate till her decease I likewise constitute make ordain my said wife Susannah Edgar my only and sole Executrix of this my last Will and Testament .. confirming that this and no other to be my last Will and Testament In Witness whereof I have hereunto set my hand & seal

Item It is my will and desire that all the remainder of Debts which are owing unto me by Bonds Bills or on any account whatsoever shall be equally divided as soon as collected amongst my Six Sisters to wit MILLEY JETT wife of WILLIAM JETT: ELIZABETH WHITEHEAD wife of WILLIAM WHITEHEAD: NANCY JETT, PHEBE DOORES Wife of JAMES W. DOORES, SUKEYJETT and DICKY JETT to them and their heirs. And it is my further will and desire that should my Sister Milleys Husband William Jett return so to cohabit with her from whence he has been absent from some time to parts unknown then and in that case it is my desire that the dividend of the moneys as above described to be her part & shall be committed to the care and possession of my Father WILLIAM JETT to be dealt out to her or her children as he may judge is convenient for their benefit.

Item I give and bequeath unto my father William Jett my horse called Toby to him and his heirs.

I constitute and appoint my Brother Matthew Jett and my Brother in Law James W, Doores Executor of this my last will and Testament revoking ,, . in Testimony Whereof I have hereunto set my hand and seal this eighteenth day 01 April one thousand eight hundred years.

TO ALL PEOPLE I WILLIAM JETT and SUSANNA my Wife send Greeting. Know ye that I William Jett and Susanna my Wife of Saint Marks Parish in the County of Culpeper for natual love which we bear towards our loving Son EDGAR JETT of Parish and County aforesaid have given unto our Son Edgar Jett and his heirs forever Two hundred acres of land conveyed to me by Deed from TOBIAS WILHOIT bearing date the 28th of November 1759 and is bounded Begining at a white oak standing in ROBERT BEVERLEY Esqr. Meander Run Mountain Tract on the GERMAN ROAD in a line of a Patent granted to MARTIN WALK and TOBIAS WILHOIT thence North to the Deviding line of THOMAS POINER decd to the beginning . . . William Jett At a Court held for Culpeper County the 19th of April 1779 This Indenture ordered to be recorded
