MILLER, Margaret (widow). Deed of gift dated 12 June 1733. William Barton by his deed dated June 13, 1688, granted to William Hungerford and Margret his wife, the natural born dau. of sd. William Barton, land called Bartons Wood Yard, 100 acres; also the tract called Capell, 100 acres. After execution of the deed William Hungerford died and the two tracts became the sole property of said Margret and she now gives same to her son Barton Hungerford. (Land: M#2.343)

MILLOR (MILLER), John (tailer), in Stafford Co., Virginia, appoints his two sons [in law?], Benjamin and Francis Posey (carpenters), as his attorneys, to sue anyone indebted to him on debts due his late wife Mary Miller, dec'd., and to pay her debts. Signed 9 Jan 1730. (Land: M#2.241; also see 242)

MILLER, Jacob. Next of kin: Barton Hungerford, Thomas Hungerford.

Admr.: Sarah Miller. (Inv.: 23.28; 14 Dec 1737; 2 March 1737)

MILLNER, Thomas, Avon River. In his will he left to Joseph Harrison, all estate in Md. To John Thomkinson, 200 acres called *Redd Clift* in Westmoreland Co., Virginia. Ex. not named. Test: Thos. Robinson, Samuel Palmer. (Will: 1.132; 23 Feb 1659; 12 Feb 1661)

MILLNER, Madam Anne, late wife and admrix. of Isaac Miller (?Millner) and Peter Pagan, merchant of London, appoint Thomas Crabb of Maryland as attorney, 5 Dec 1715. (Ct. SLand: F#2.94)

MILSTEAD, Edward, age 19 yrs. Servant of William Chandler, 12 Jan 1674. (Ct.&Land: F#1.41)

MILLSTEADE, William, son of Edward and Susanna Millsteade, born 20 July 1685. (Ct.&Land: P#1.208; QRev.11)

MILSTEAD, William and his now wife Elizabeth. Deed dated 12 June 1733; from Thomas Milstead, 130 acres called Winter's Imployment. (Land: M#2.344)

MILLSTED (MILLSTEED, MILLSTEAD), Edward Sr., planter. In his will he mentions son Edward; wife Mary, extx.; John and William Milstead; James Mordock; Benjamin Shakalit; John Grew. To children not herein mentioned, 1 s. (Will: 20.876; 14 Dec 1733; 17 Jan 1733) Next of kin: Edward Millstead, William Millstead. Admr.: John Millstead. (Inv.: 18.37; ----; 9 --- 1734)

MILSHAW, John, age 15 yrs. Servant of John Ward, 11 March 1678. (Ct.&Land: H#1.129)
